#### TITLE VIII—WATER AND POWER Subtitle A—Reclamation Title Transfer

SEC. 8001. PURPOSE.


The purpose of this subtitle is to facilitate the transfer of title to Reclamation project facilities to qualifying entities on the completion of repayment of capital costs.




# Why is SCBID pursuing a Partial Title Transfer?


SCBID is pursuing title transfer to eligible Project facilities, canals, laterals, pumping plants, rights of way, easements, lands, and associated structures located within Blocks 1, 2, and 3 and various other locations **in order to reduce administrative costs and increase operational efficiencies.**

## Written Notice to Congress

Reclamation is authorized to convey to a qualifying entity all right, title, and interest of the United States in and to any eligible facility if:

- (1) Reclamation determines that the entity and facilities qualify under 43 U.S.C. 2902, et seq.; and
- (2) not later than 90 days before the date on which Reclamation makes the conveyance:
- (a) Reclamation submits to Congress a written notice of the proposed conveyance and a description of the reasons for the title transfer; and
- (b) A joint resolution by Congress disapproving the conveyance is not enacted before the date on which Reclamation makes the title transfer.



### Where are we in the process?

- 1. Board Resolution completed
- 2. Reclamation approval completed
- 3. MOA and Funding agreement will be executed soon
- Public outreach being initiated (today, for example)
- 5. Cultural resource survey contract



### **Time Frame**

- 1. Started in January 2023 with board resolution and data gathering
- 2. September 2023 received BoR approval and engaged CR contractor
- 3. Anticipated CR completion October 2024
- 4. Balance of process by 2026?
